Whips and calling permitted when necessary.

All tests will be ridden in a small arena unless enough entries to warrant full size arena.

Only riders who's signature is on this entry form are allowed to ride entered horses.

CD must be supplied for classes 11, 12 & 13, labeled and cued to play with any instructions printed clearly.
